**NOTICE INVITING TENDER (NIT) EMPANELMENT OF COURIER SERVICE
AGENCY FOR REC**

Rural Electrification Corporation Limited (REC), a Government of India Enterprise invites **'Sealed Quotation'** for courier services of reputed agencies like, BlazeFlash Couriers, DTDC, M/s Skylark Express, M/s First Flight Couriers, M/s Over Nite Express Ltd. etc. for a period of two years.

- 1.1 The sealed bid shall be signed by a person duly authorized on behalf of the bidder Organization and shall be sent to :-

- 2.1 The sealed bids will be received by REC upto 3.00 PM on 10.05.2010. Any bid received by the REC after the prescribed deadline shall be rejected /over-looked irrespective of rates.
- 2.2 The bids will be opened in the presence of the representatives of the firms on 10.05.2010 at 4.00 PM.
3. Earnest Money (EMD) of Rs.5,000/- should accompany the bid documents. The EMD shall be paid in the form of Demand Draft/Banker Cheque from a Nationalized bank/Scheduled bank in favour of Rural Electrification Corporation Limited, New Delhi. Any bid not accompanied by valid EMD shall be deemed to be invalid and will be rejected by REC.
- 3.1 The EMD shall be forfeited If the bidder withdraws his bid during the period of bid validity.
- 3.2 EMD of successful bidder shall be retained towards security for the performance of the contract.

4. The bid shall remain valid for a period of 45 days from the date of receipt of the bid.
5. The dak will be picked up from REC office at SCOPE building at Lodhi Road and Palika Bhawan, R.K.Puram, New Delhi, on daily basis as a routine and at late evening hours in exceptional cases, whenever so requested by REC authorized officers.

6. RATES AND PRICES

6.1 Bidders should quote item-wise rates/prices for courier service of different stations mentioned in Annexure-1.

6.2 All statutory duties and taxes (including excise and customs) Sales Tax and other charges will be payable by the bidder. However, any variation in taxes from the closing date of tender will be payable by REC.

6.3 Price quoted shall be firm and any variation in rates, prices or terms during validity of the offer shall require forfeiture of the EMD.

7. PENALTY FOR DELAYS IN SUPPLY/COMMISSIONING

7.1 Time is essence of the contract. The successful bidder must supply goods within the stipulated time. Failure to supply on or before the stipulated date will entail a penalty equal to 0.5% of the value of contracted package price per day subject to maximum of 5% of total contract value.

In the case of delay in compliance with the order beyond 5 days of the stipulated time period, REC will have the right to cancel the order.

8. PRE-QUALIFICATION CRITERIA

8.1 The bidder must be an authorised agent/franchise of any one of the reputed agencies, e.g. M/s Blaze Flash, M/s DTDC, M/s First Flight Courier, Skylark Express, M/s Over Nite Express Ltd.etc. with spread/service across India.

8.2 The bidder must have provided similar service to at least 3 public/pvt. Ltd. companies of repute each year during 2007-2008, 2008-09 and 2009-10.

9. EVALUATION CRITERIA

9.1 The bidder quoting lowest consolidated average price will qualify for award of contract.

10. Terms of payment

10.1 Payment will be released on monthly basis, within a fortnight of receipt of bill and a certification of satisfactory services by concerned REC authorized officer.

11. CONCILIATION/ ARBITRATION

- 11.1 If any dispute (s) or difference (s) of any kind whatsoever arise between the Parties, the Parties hereto shall negotiate with a view to its amicable resolution and settlement through a committee appointed by CMD, REC.
- 11.2 In the event no amicable resolution or settlement is reached between the parties within 30 days after receipt of notice by one party, then the disputes or differences as detailed above shall be referred to and settled by the Sole Arbitrator to be appointed by CMD, REC.
- 11.3 Notwithstanding the existence or any dispute or differences and/or reference for the arbitration, the Contractor shall proceed with and continue without hindrance the performance of the work under the contract with due diligence and expedition in a professional manner and the payment due to the Contractor shall not be withheld on account of such difference of arbitration proceedings unless such payment is a subject matter of the arbitration.
- 11.4 The arbitration proceedings shall be in accordance with the prevailing Arbitration and Conciliation Act, 1996 and Laws of India as amended or enacted from time to time.
- 11.5 The venue of the arbitration shall be New Delhi, India. The fee & other charges of Arbitrator shall be determined by the arbitrator in terms of the Act and shall be shared equally between the parties.
- 11.6 The arbitrator will give the speaking and the reasoned Award. The parties will not be entitled to any pendente-lite interest during arbitration proceedings.
12. No alternative offer shall be considered.
13. Any cutting will not be entertained and bid may be rejected without assigning any reasons thereof.
14. REC reserves the right to cancel/withdraw this invitation for bids without assigning any reason for such decision. Such decision will not incur any liability whatsoever on the part of REC consequently.
